
# Legal position of data

- You cannot 'own' data: data is no 'property'
- Collection of data can be protected as a database right





### Parties in a private blockchain






### Private blockchain

• A <u>private</u> blockchain, where access to it is controlled (which may mean that there is more central control);

and

 A <u>public</u> blockchain, where anyone can download the software, view and participate.

### Parties in a private blockchain

What to arrange:

- What are the objectives of the parties in the blockchain; why are they working together?
  - Traceability

(transparent to public, reduce damage food recall)

- Data Sharing
- Payments



### Parties in a blockchain

What to arrange:

- Who can do what with the data provided:
- Data transfer agreement:
  - Which data is provided
  - Guarantees?
  - Data protection
  - Rights to use, for what purpose, exit rights
- New data: who is entitled to which information



### Parties in a blockchain

What to arrange:

- Exit / one or more (all) parties
  - copy of own data, data migration assistance
- disputes; (inter)national; jurisdiction and enforcement



### Building the private blockchain

Service provider /operator

- What to arrange:
  - Building the platform, service levels, performance
  - Management and privacy identification (anonimyzation)
  - Governance: personal data: right to be forgotten data that is stored cannot be altered
  - (New generated) data: who can do what, under which conditions?



### Building the private blockchain

Service provider /operator

- What to arrange:
  - Who makes the descisions regarding the blockchain
  - Intellectual property (trademarks, copyright, patents)
  - Liability, who is liable for what

# Challenges

- Using new technology:
  - R&D / marketing sees opportunities
  - Legal sees risks, unknown territory, difficult to oversee liabilities
    - E.g. you cannot 'own' data (except database protection)
- How to handle this:
  - Translate the unknown to a legal framework we do know
    - E.g. data sharing agreement
